INFORMATIONAL REPORTS

Elementary Robotics Update

Marcy Thayer and members of the elementary robotics team gave an update on the new elementary team. Students discussed what they learned and gave a demonstration of a motorized lego car they built. Mrs. Thayer is also looking at adding a middle school robotics team next year with available grant funding.

Character Strong Curriculum

SEL was a concern on the stakeholder surveys earlier this year. The district is able to use ESSER III funds to purchase the curriculum.
